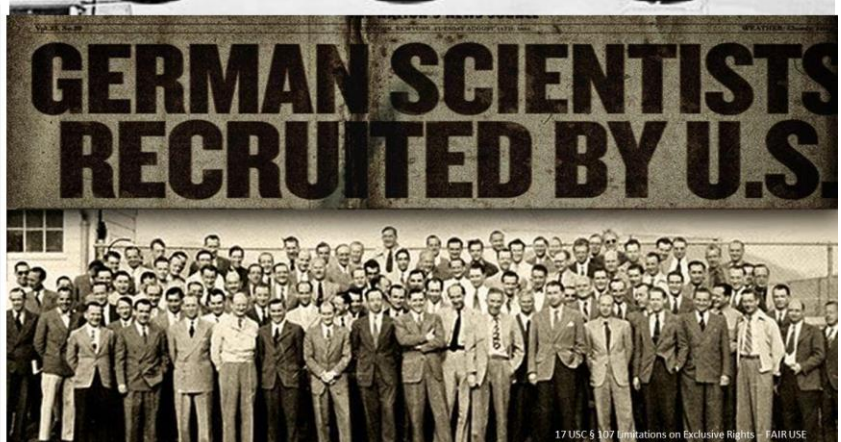

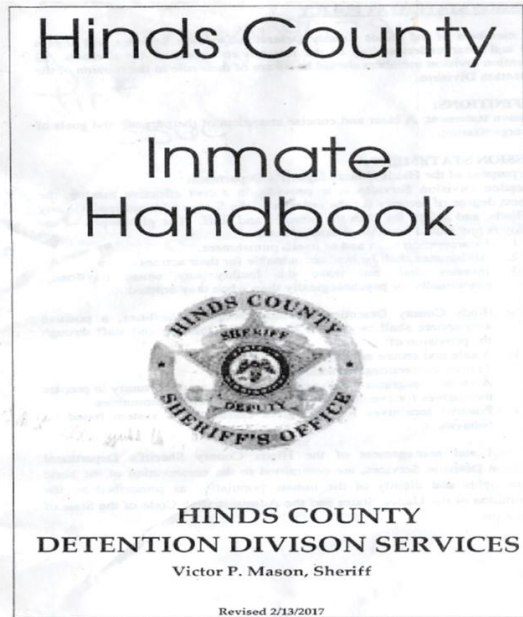

MEDICAL/DENTAL:

As an inmate, you are eligible for medical and/or dental services as needed to maintain your health (optional/corrective services are not available). There is a ten (\$10) dollar fee for each physician dentist and mental health visit. You will not be denied medical services because of your inability to pay. Health Appraisals will normally be performed by the medical personnel within 14 days of incarceration. You are not allowed to have medication in your possession, without written permission from the Nurse therefore, you will receive prescription medication at regular "Med Rounds" Inmates shall not be forced to take any medication. However, any inmate who may become violent or experience medical difficulties without medication will be isolated and monitored until instructed otherwise by the Medical Staff.

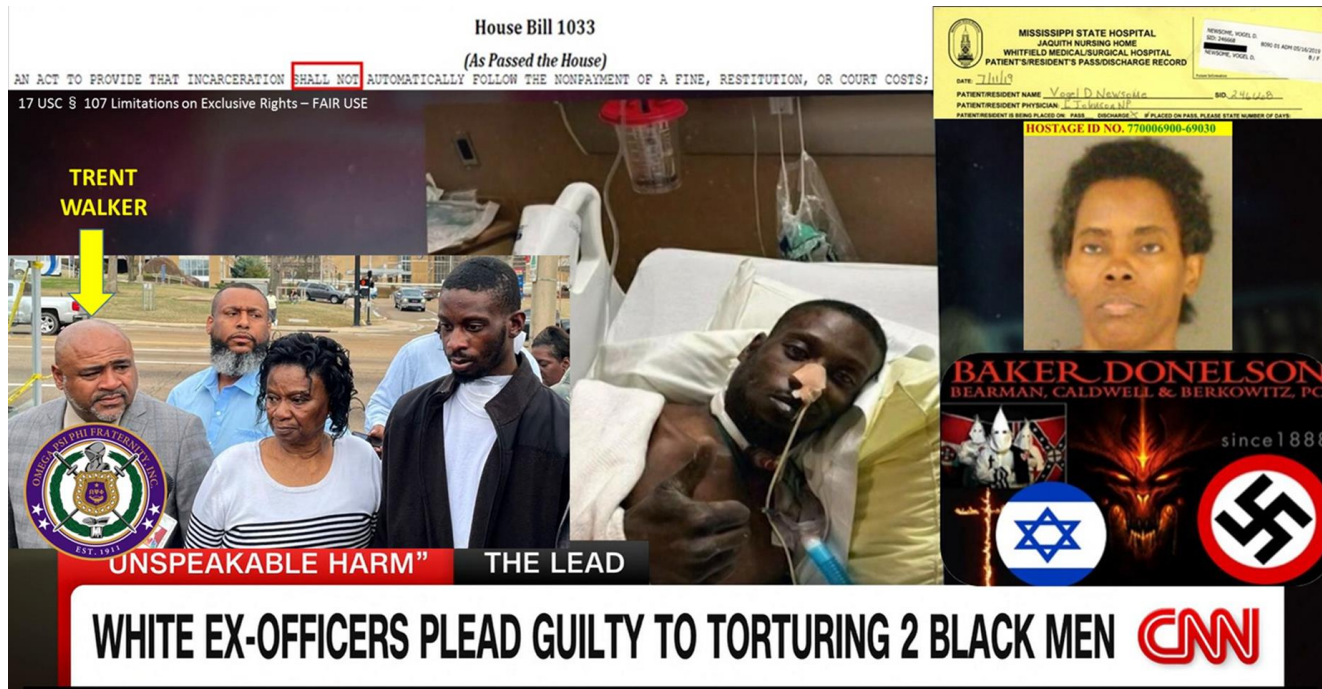
(As Passed the House)

AN ACT TO PROVIDE THAT INCARCERATION SHALL NOT AUTOMATICALLY FOLLOW THE NONPAYMENT OF A FINE, RESTITUTION, OR COURT COSTS; TO PROVIDE THAT THE AGGREGATE TOTAL OF THE PERIOD OF INCARCERATION IMPOSED PURSUANT TO THIS SECTION AND THE TERM OF THE SENTENCE ORIGINALLY IMPOSED MAY NOT EXCEED THE MAXIMUM TERM OF IMPRISONMENT AUTHORIZED FOR THE OFFENSE; TO AMEND SECTION 63-1-53, MISSISSIPPI CODE OF 1972, TO REVISE HOW NOTICE OF DRIVER'S LICENSE SUSPENSION IS PROVIDED; TO AMEND SECTIONS 99-19-20, 99-37-7 AND 47-1-1, MISSISSIPPI CODE OF 1972, IN CONFORMITY TO THE PRECEDING SECTIONS; TO AMEND SECTION 63-1-71, MISSISSIPPI CODE OF 1972, TO LIMIT THE SUSPENSION OF DRIVING PRIVILEGES FOR VIOLATIONS OF THE UNIFORM CONTROLLED SUBSTANCES LAW TO VIOLATIONS OF DRIVING UNDER THE INFLUENCE OF CONTROLLED SUBSTANCES; TO AMEND SECTION 47-7-3, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT AN OTHERWISE INELIGIBLE INMATE FOR PAROLE SHALL BE ELIGIBLE FOR PAROLE IF AN INMATE HAS NOT BEEN CONVICTED OF COMMITTING A CRIME OF VIOLENCE, DRUG TRAFFICKING OR AS A HABITUAL OFFENDER AND HE OR SHE HAS SERVED AT LEAST 25% OF HIS OR HER SENTENCE; TO AMEND SECTION 9-23-15, MISSISSIPPI CODE OF 1972, TO REVISE ELIGIBILITY FOR DRUG COURTS; AND FOR RELATED PURPOSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

SECTION 1. (1) Incarceration shall not automatically follow the nonpayment of a fine, restitution, or court costs. Incarceration

Karl Brandt and six other defendants **were convicted, sentenced to death, and executed**; nine defendants were convicted and sentenced to terms in prison; and seven defendants were acquitted.

The **material presented** in this project includes **case file documents** (the briefs and document books created and used in the course of the trial), **evidence file documents** (the **evidentiary documents** from which the prosecution, and occasionally the defendants, derived their exhibits), and the trial transcript.

Indictments

(25 Oct. 1946)

Four counts:

- 1 **Conspiracy to commit war crimes against humanity:** The **ordering, planning, and organization** of the war crimes and crimes against humanity charged in counts two and three. Charged against all of the defendants. The tribunal decided not to convict on this charge.

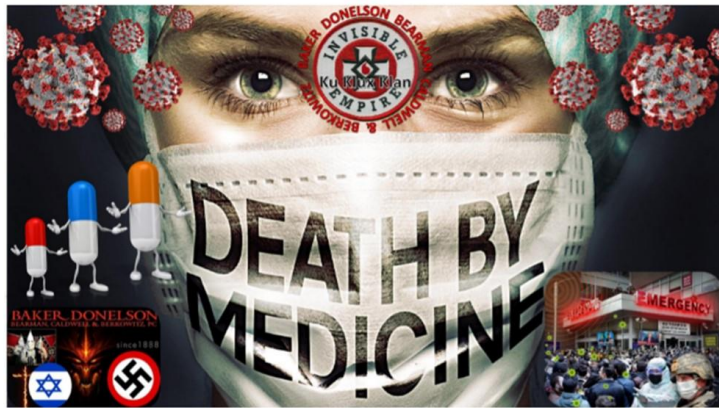

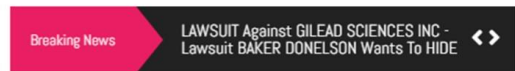

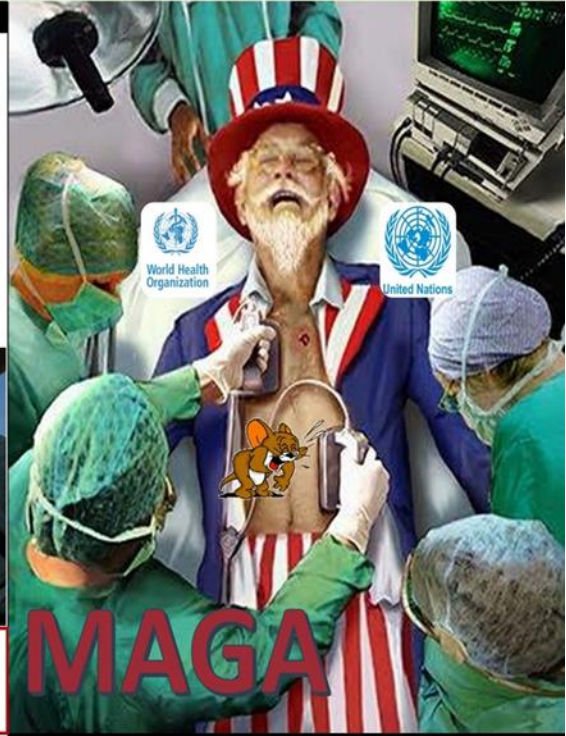

For 40 years, the U.S. government doctors behind the Tuskegee experiment tricked African-American men with syphilis into thinking they were getting free treatment — but gave them no treatment at all.



When the Tuskegee experiment first began, doctors already knew how to treat syphilis using arsenic therapy. But the researchers deliberately withheld information about treatment. They told the patients that they were suffering from "bad blood" to keep them from learning about syphilis on their own.
